1, Call Meeting to Order

2, Approve Minutes of Previous Meeting

3, Review Final Round Applications

The Committee reviewed the final round of applications:

Barbara Dickey - submitted a revised budget requesting \$58,000 for the purchase and first year operation of the Gethsemane Church for a community center

 $Caven dish\ Street scapes-requests\ \$10,\!000\ for\ benches\ for\ the\ Proctors ville\ Green\ and\ the\ Caven dish\ playground\ behind\ the\ Town\ Office$

Town Office – requests \$24,800 for digitizing the parcel maps

Town Office – requests \$36,000 for building upgrades for ADA compliance

The Committee discussed what the remainder of the funds could be used for and what role the ARPA committee might play.

Betty McEnaney moved/Wendy Regier seconded a motion to accept all the applications in the total amount of \$324,150. All voted in favor.

4, <u>Discussion of Application Submissions to Select Board</u>

George asked if the Committee wanted to make a presentation to the Select Board. Wendy suggested having the applicants come to a Board meeting. Jen suggested letting the applicants know that the Committee will be recommending their applications to the Board and said she would do that. The Committee agreed that the Board could contact the applicants if they had questions. Rick said that he thought the Select Board might review applications in February after the Town budget process.

Betty asked if any money should be held aside for Greven Field. Rick said that the clean-up and rebuild would be part of the Town's FEMA claim. Betty commented that she thought adding some fitness equipment along the nature trail would be a good addition.

5, Discussion on Vacant ARPA Committee Seat

George said that there is a vacant seat on the Committee since Stephen Plunkard has passed. The Committee discussed the vacancy and decided not to appoint a replacement since the application review is complete.
